1.0 PURPOSE

Further to the amendment of Employment Act 1955 by inserting new Section 69F – Discrimination in Employment effective Jan 1, 2023

2.0 SCOPE

Heng Huat Resources Group Berhad (HHRGB) and any subsidiaries companies thereof are committed to providing a workplace free of harassment and unlawful discrimination. **HHRGB** prohibits harassment and discrimination of our employees, and those of our customers and partners, based on race, color, age, gender, nationality, disability, pregnancy, religion, political affiliation, union membership or marital status in hiring and employment practices such as wages, promotions, rewards, and access to training. We ensure no such discrimination is part of our hiring and employment practices nor that it affects the terms and conditions of employment.
